# WHAT DO FOUNTAINHEAD ADVISORS AND FOUNTAINHEAD AM DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:
	<ul> <li>Social Security number, and financial information</li> <li>Investment holdings, investment experience and account transactions</li> <li>Financial goals and financial history</li> </ul>
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Fountainhead Capital Management LLC dba Fountainhead Advisors, and Fountainhead AM LLC (collectively, "Fountainhead") choose to share; and whether you can limit this sharing

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Fountainhead Advisors and Fountainhead AM are related by common ownership and management			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  Our nonaffiliated business partners include our custodian, Charles Schwab & Co., Inc.			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  We do not have any such agreements in place.			

## Other important information

You may have privacy protections under applicable state laws, including those for California residents. To the extent the state laws apply, we will comply with them when we share information about you, and in some case may be limited by you.

#### California Residents:

The California Information Privacy Act provides additional protections to control whether we share some of your personal information. In accordance with California law, we will not share information we collect about California residents with outside companies, except as permitted by law, such as with the consent of the customer or to service a customer's accounts.

#### **For Insurance Customers**

The term "Information" in this part means customer information obtained in an insurance transaction. We may give your information to state insurance officials, law enforcement, group policy holdings about claims experience or auditors as the law allows or requires. We may give your information to insurance support companies that may keep it or give it to others.
